In the period 2000-2011 the **total number of hospital beds** in the European Member States dropped off by 21%.

Only the Netherlands, Austria and Greece showed a slight countertrend.

In 'EU15' the reduction in the **number of acute care beds** was in average 17%, comprised between -3,5% in Spain and -27,9% in Italy. The only country characterized by an increase was the Netherlands, where the **number of acute care beds** increased by 15%.

The decrease in the **number of acute care beds** in ´EU13`, was in average equal to 22%. The countries that registered the main decrease were Latvia (-48,7%), Estonia (-38,4%), Lithuania (-29,5%), Hungary and Malta (-28,2%).

Between 2000 and 2011, while the **total number of beds** declined, the **number of private inpatient hospital beds** increased, in particular in most 'EU13' Member States.

However, as showed in the table in the next page, **private hospital beds** represented in 2011 the 33% of the **all hospital beds**. The highest rates, where data are available, were in Germany (59.4%), Cyprus (49,2%) and France (37,8%) and the lowest were in Romania and Hungary (almost 3,0%) and Lithuania, Croatia and Slovenia (almost 1,0%).

In EU13 Member States, 11% (in average) of hospital capacity was represented by **private hospital beds**, ranging from almost 1% (Croatia, Lithuania and Slovenia) to 14% (Czech Republic). The only exceptions were Poland and Cyprus, where the **percentage of private hospitals beds** is respectively 27% and 49%.
